### FORM OF TAX-EXEMPT COLLECTION ACCOUNT MONTHLY DISTRIBUTION DATE CERTIFICATE

This Monthly Distribution Date Certificate (the "Information Form") is being provided with respect to the Kentucky Higher Education Student Loan Corporation Student Loan Asset-Backed Notes, Series 2016-1 (the "Corporation" and the "Notes") pursuant to Section 5.03(c) of the Indenture of Trust dated as of June 1, 2016 by and between the Corporation and The Bank of New York Mellon Trust Company, N.A., as Trustee (the "Indenture"). All capitalized terms used in this Information Form and not otherwise defined shall have the same meanings as assigned to such terms in the Indenture.
