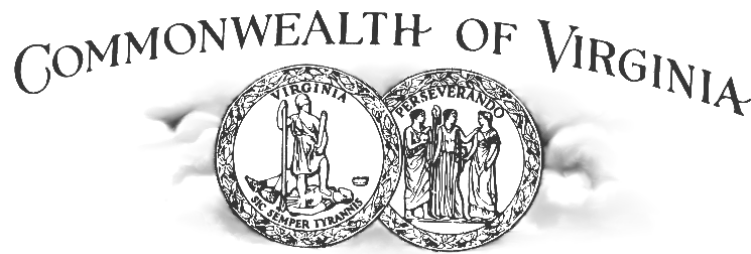

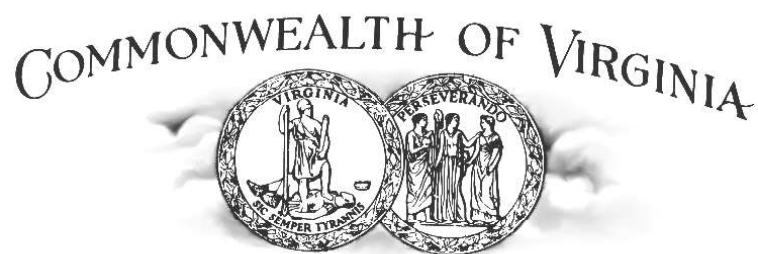
ORDER GRANTING A LICENSE
